



L.O.V.E. 5k Run TABLE/DISPLAY SPONSOR CONTRACT

I, _____ as the authorized representative of _____, a sponsor ("Sponsor"), of the L.O.V.E. 5k Run ("the Event"), understand and agree that I, my organization, employees, assistants, coworkers, heirs, or assigns, HOLD HARMLESS Laurencia's Victory, (d/b/a the L.O.V.E. 5k Run), its organizers, directors, other sponsors, insurance carriers, and property owner (collectively, "Laurencia's Victory") as well as the City of St. Michael, MN in the case that I or any person working with me suffer any damages to goods, wares, or merchandise; or accident, illness or injury including death within the confines and context of the Event. I will not file any claims against Laurencia's Victory, its organizers, directors, other sponsors, insurance carriers, and property owner nor the City of St. Michael and I or my insurance carrier will pay any and all medical bills associated with illness or injury suffered at the Event.

By participating in the Event, all Sponsors agree to comply with the following: (1) No parking is allowed in the Public Works Building parking lot; (2) Sponsor may distribute or display Sponsor's product to the public at the Event. In addition, Sponsor may display Sponsor's logo and/or slogan that is an established part of the Sponsor's identity. Sponsor displays are to be neat and orderly and confined to an area designated on the day of the Event by Laurencia's Victory. Laurencia's Victory reserves the right to prohibit items, signs, banners, or groups as determined at Laurencia's Victory's sole discretion; (3) By signing this contract and participating in the Event, Sponsor agrees to observe and abide by all rules, regulations and/or notifications of the City of St. Michael; (4) Personal property of the Sponsor is the sole responsibility of Sponsor; (5) All Sponsors are expected to conduct themselves in a professional, courteous manner; (6) Sponsors are required to clean their displays/areas upon conclusion of the Event; (7) All Sponsors understand that Laurencia's Victory has no control over the Event attendance or inclement weather. The L.O.V.E. 5k Run is a Rain or Shine event and once signed, this agreement is binding. All payments made to Laurencia's Victory cannot be returned or refunded.

By signing this agreement, Sponsor agrees to abide by all clauses set forth in this agreement. Failure to comply will give Laurencia's Victory and/or authorized agents of Laurencia's Victory the authority to terminate this agreement. Sponsor agrees to immediately vacate premises and forfeit any and all fees paid for the privilege of participation in the Event upon verbal notice by Laurencia's Victory of violation of this agreement. This agreement may not be altered in any way without written permission of Laurencia's Victory.
